If you're tendering for Commonwealth Government work you must provide random drug testing throughout your organisation, to be code compliant. This has meant a rapid need for processes, management training, and education on site. Further, there needs to be help available for workers who may test positive, or are in need.

The Building Trades Group Drug & Alcohol Program (BTGDA) has stepped up and created a training and communications program in conjunction with unions and employers. This program clarifies the testing processes and legislation, while creating a conversation on site so the workers and can make an informed decision about their own safety and impairment.

The ideal outcome is a safe workplace, and The Building Trades Group Drug & Alcohol Program (BTGDA) is giving workers and employers the tools to deliver this. We also offer a pathway for counseling and rehabilitation in partnership with Foundation House for the workers who want help.

ToolBox Talk Program



The Toolbox Program is a fast and easy way to establish a relationship with The Building Trades Group Drug and Alcohol Program (BTGDA).

This involves onsite education where workers and management receive educational materials that introduce the workforce to new drug and alcohol policies.

Impairment Training Program



Workplace Impairment Training (WIT) is an awareness program for site workers that features talks, films and supporting materials.

It explains policies, procedures, legislation, and impairment windows for drugs and alcohol, enabling the workforce to be able to recognise impairment in themselves and employers to be compliant and offer support to their workers.
